TVCCA	Ms. Hanson received a request for a donation of \$2,000.00 of the ARPA funds from TVCCA.
Tax Attorney	A closure judgement was received for 4 Pequot Trail. Once the title is received the Town can move forward with auctioning off the property.
Beach Dale Pond	Ms. Hanson's request to draw down Beach Dale Pond was denied. The DEEP Commissioner responded that if Ms. Hanson sends in a request next year, they will agree to a drawdown of Beach Dale Pond and Beach Pond.
Nip Bottles	As of October 1 st , the CT Bottle Bill will go into place requiring anyone selling nip bottles to add a 5-cent surcharge. The money collected will go to the Towns in two lump sums. The first lump sum will be sent to Towns in April 2022 and the second will be sent in October 2022. The money the Town receives from this can be used for litter control.
